## Moving families through changes during a divorce.

Children Cope with Divorce is a four-hour educational seminar, mandated by the courts, for all parents filing for divorce, separation, or change of custody. The program provides support and encouragement to the parents while placing an emphasis on the needs of the children involved. The seminar is led by a co-facilitator, who is a Master's prepared professional. Each parent should schedule his/her class within thirty days of legal filing. At the end of each seminar, clients are given a certificate of completion, and their attendance will be reported to the courts.

- How families experience divorce
- Typical reactions of children
- Developmental needs of children
- Pitfalls to avoid
